## Scotia True Value Hardware to Close



A 20-year tradition in Scotia will end in July when the True Value Hardware store closes. Linda David will manage the final month of the store's operation, with the help of an inventory liquidation firm. Her husband, Paul David, is one of three brothers who ran the business along with an industrial, business-to-business hardware company. One brother died last fall, and Paul and Linda David want to retire to Kentucky, where a daughter lives.

"We want to thank the community and the area for 20 wonderful years," Linda David said. A native of Southern Humboldt, her

memories of Scotia extend to her childhood in the 1950s. "My family would come to Scotia for groceries and banking," she said. The community of Bull Creek, where she grew up, bused people in to use the Scotia pool. "We played on the train. There's been a lot of change and also some things that have stayed the same," like the family-focused flavor of the community, she notes.

The hardware business was very successful, she says, and grew over time, adjusting to changes in the economy. "We're not going out of business, we're closing because we want to retire," she says, praising the employees who have staffed the store over the years. **Continued on Page 4.**

Scotia marked the completion of the first home purchase in mid-June, when Dale Mensing, whose father was born half a block away in the old Scotia Hospital, took over the keys, along with wife Karen. All 270 houses will be sold in phases over the next four to five years, according to current plans.

## Member Profile: Coast Central Credit Union Strong and Helping the Community

Manager Cindy Hicks at the Fortuna branch of the Coast Central Credit Union has no trouble listing the benefits her employer offers to the area. "We're a cooperative, so the members are the owners," she says, noting this "fundamental difference" means lower interest rates when borrowing money, and higher interest rates when investing, since profits aren't channeled to shareholders. Other advantages include

the organization's size and strength. "We have 13 branches and a billion dollars," she notes. "We're five-star rated, that's as high as you can go," she says of the Bauer Financial Service system that rates banks and credit unions throughout the U.S., which people can check online for free at bauerfinancial.com.

"We're locally managed," Hicks continued, pointing out that decisions are made by a local board. And, the credit union funnels about \$200,000 a year into the community, helping out with non-profit organizations and fundraisers. "We give to about 80 percent of the activities in Humboldt County" she says, as well as supporting activities in Del Norte and Trinity counties. She indicates her office, which is filled with gift baskets she has assembled to benefit various upcoming silent auctions and other activities. Finally, there's the quality of service that Hicks believes sets the credit union apart. "We go above and beyond," she says, taking the extra moment to build a one-on-one relationship. "It's like family here," one teller laughed, noting how the branch was decorated to mark Hick's 60<sup>th</sup> birthday recently. "This is why I worked here half of my career," Hicks says of her 40 years in banking, 20 of them in management with the credit union – it's the personal relationships among the employees and customers. All this, she thinks, adds up to the high level of satisfaction customers report in relationship surveys and Peoples' Choice awards offered through the *Times-Standard* and *North Coast Journal* newspapers.

In her 11 years as manager at the Fortuna branch, Hicks has served on a number of boards. A major passion is helping high school youth and college students. She works with the schools and other organizations such as Decade of Difference to give young people practice in mock job interviews, advice on how to present themselves, and tips on social media behavior and what the work world seeks and expects in employees. "They will be taking over one day," she says of her mentoring work and the good sense it makes to ensure young people get a solid start.

# Scotia Hardware Continued from Page 1:

The building formerly housed a Coast to Coast hardware store, which burned in the 1992 fire that destroyed the Scotia shopping center following an earthquake. After standing empty, it opened as a True Value with the David brothers as owners. Becky Nicholson, the longestserving of the store's six employees, began in 2000 working in accounting. "The position of manager just sort of evolved," she said of her most recent title, as she tackled the various jobs including ordering and checking in new stock.

Nicholson sold her Rio Dell home in preparation for a move to Washington State where her husband had taken a job, in a timeframe that coincided with the closure of the store. The Town of Scotia owns the hardware store property and has been trying to secure a buyer.




## Town of Scotia Continued from Page 1.

Meanwhile, the Community Services District board of directors is busily assuming responsibility for the water and wastewater services, parks and recreation facilities, historic structures and other properties it formally took over from the Town of Scotia corporation in May. The five-member board meets at 5:30 p.m. on the third Thursday of each month, as well as at specially-called meetings when required. The board includes president Rick Walsh, vice president Gayle McKnight, and

directors Diane Bristol, Paul Newmaker and Susan Pryor.

Handling the day-to-day work of running the community are general manager Steve Tyler and assistant general manager Leslie Marshall, both contract employees hired by Planwest Partners, Inc., an Arcatabased consulting firm offering services to governmental entities. Attorney Tracy Boobar with the Law Offices of Nancy Diamond, also in Arcata, provides legal counsel. Tyler and Marshall staff the office, which is also where board meetings are held, at 122 Main Street (in the suite of facilities that includes the post office





A recent meeting saw directors addressing the potential injuries that could come from people climbing on the lumbering equipment on display in the park area adjacent to the museum. While noting that local families and visitors of all ages come to the park to climb on the equipment and take photos, directors voiced concern for the dangers of people falling, getting cut on sharp edges, and being exposed to potentially harmful substances in the paint and materials.

Fencing will be erected and warning signs posted as an initial measure while the board examines possible ways to address the issue more permanently, which range from refurbishing of the displays, estimated to cost hundreds of thousands of dollars, to the possible sale of these items. A delegation from the Mill Valley Historical Society was in attendance, noting their continued interest in purchasing the locomotive because it served in a lumbering operation on Mt. Tamilpais before being moved to Scotia, but agreeing that there are substantial costs either party would need to invest in the care of the machinery.
